Thank you for your prompt response and fulfillment letter dated August 10, 2026.

Upon reviewing the attached PDF records, we noted that the delivery contained the revised Water Purchase Contract, email correspondence with the City of Higginsville, and the July 20, 2026 Board Minutes. However, Items 1 and 2 of our initial request were not addressed in the attachment or fulfillment letter:

1. **Item 1 (Water Rate Study):** Were any reports, summaries, or presentation materials regarding the 2025/2026 water rate study provided to or retained by PWSD No. 2? If PWSD No. 2 is not in possession of any documents responsive to Item 1, please confirm in writing that no responsive records exist in the District's possession.
2. **Item 2 (Financials/MOUs):** If PWSD No. 2 did not contribute financially to or execute an MOU for the study, please confirm that no responsive financial/contractual records exist for Item 2.
3. **Item 3 (Internal Communications):** Please confirm whether the search for communications included internal correspondence (emails, memos, board communication) within PWSD No. 2 regarding the water rate increase between January 1, 2026, and August 9, 2026.
4. **Item 4 (July 20 Board Packet):** Additionally, please provide the complete Board Information Packet, agenda, and all supporting memos, addendums, or documents provided to the Board of Directors prior to the July 20, 2026, meeting regarding the resolution to approve the Water Purchase Contract with the City of Higginsville.

Thank you for your assistance in clarifying these remaining items for our audit log. We look forward to your response.
